President's Message

Dear Fellows and colleagues,

I feel honoured and humbled to be writing my first message as Academy President.

My profound gratitude goes to Immediate Past President Prof Chak-sing Lau for his great mentorship and trust, and to all fellow Council members for their confidence in me. I am also delighted to introduce our new team of Officers: Vice-President (General Affairs) Dr Yu-fat Chow, Vice-President (Education and Examinations) Prof Paul Bo-san Lai, Honorary Secretary Dr Wing-cheong Leung, Honorary Treasurer Prof Eric Wai-choi Tse, and Editor Prof Martin Chi-sang Wong. You will find their introductions in this issue and on the Academy website (<https://www.hkam.org.hk>), which has recently been revamped under the incredible effort of the Secretariat.

Medical and dental practices are undergoing momentous changes amid the pandemic, with emerging fields, such as genetic and genomic medicine, posing both opportunities and challenges, and evolving public needs and expectations informing our future standards of practice. In this new environment, I believe there are at least three things the Academy should do.

First, we have to revisit our training paradigm to ensure the skills and knowledge we intend to instil are fit for purpose, and that the way we do so is effective. To this end, we are working on an online educational platform to enhance the learning experience of our Fellows. Deepest appreciation must again be given to Prof Lau for his tireless lobbying efforts in securing new government funding for this purpose. The online platform, tentatively named eHKAM, is expected to be launched in late 2021, and will, in conjunction with the HKJC ILCM, provide leverage for pursuing the idea of establishing an education office of the Academy.

Second, we have to go beyond skills and knowledge by focusing more intently on ethics and professionalism, and cultivating among our Fellows and trainees professional attitudes and behaviours that will enable them to embrace all these changes. The Academy's Professionalism and Ethics Committee is presently formulating best practice guidelines as a foundation to promote good practice in various aspects.

Third, we need to re-examine and realign connections along the necessary continuum between undergraduate education, postgraduate training, and clinical service needs, particularly in the context of technological advancement, evolving modes of practice, and changing societal expectations. We shall strengthen and expand strategic ties with local, regional, and overseas counterparts who share this belief.

As we enter the Year of the Ox, the Academy will continue to serve the community, starting with the provision of online vaccination training for healthcare professionals participating in the territory-wide COVID-19 Vaccination Programme. And before we resume meeting face-to-face again at the Academy Building in the not-too-distant future, may I wish you and your families good health, peace, and happiness.

Take care and stay vigilant, body and spirit.

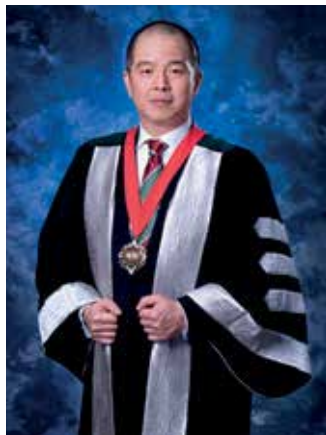

Prof Gilberto Ka-kit Leung

President



Prof Gilberto Leung is Tsang Wing-Hing Professor in Clinical Neuroscience and Associate Dean (Teaching & Learning) of the Li Ka Shing Faculty of Medicine at The University of Hong Kong (HKU). He holds a MS and a PhD from HKU, and a LLM in Medical Law and Ethics with Distinction from the University of Edinburgh. He works as an Honorary Consultant Neurosurgeon at Queen Mary Hospital, specialising in endoscopic neurosurgery. His research interests include neuro-oncology and neuroprotection, as well as medical education, law, and ethics. Prof Leung served the Academy as Vice-President (Education & Examinations) from 2016 to 2020, and he is Co-chairman of the Academy's Professionalism and Ethics Committee.

One of the goals of Prof Leung's tenure as President of HKAM is to further enhance the connections and dialogues between undergraduate education, postgraduate training, and clinical service needs in the context of technological advancement, evolving modes of practice, and changing societal expectations.

Dr Yu-fat Chow

Vice-President (General Affairs)



Dr Yu-fat Chow is a specialist in anaesthesiology qualified in Hong Kong, Australia, and New Zealand, with interests in cardiac and paediatric anaesthesia, trauma, resuscitation, and sedation. He is the consultant anaesthetist in the Queen Elizabeth Hospital and the Hong Kong Children's Hospital.

In addition to clinical anaesthesia, Dr Chow has actively participated in areas of medical education and simulation. He founded the multidisciplinary Hong Kong Society for Simulation in Healthcare and the Resuscitation Council of Hong Kong. He was the Chairman of the Board of Education before he became the President of the Hong Kong College of Anaesthesiologists from 2011 to 2015. He was previously the Honorary Treasurer of the Academy.

Dr Chow, together with the Officers of the Academy, will assist the President to foster the well-being of all Academy Fellows, and will continuously enhance the corporate management of the Academy. As such, we can fulfil our key responsibilities in the specialist training for the Hong Kong doctors and other scholarly activities of the Academy.

Prof Paul Bo-san Lai

Vice-President (Education and Examinations)



Prof Paul Lai is the Medical Director, Quality & Safety at The Chinese University of Hong Kong (CUHK) Medical Centre. He graduated from CUHK and received surgical training in Hong Kong and Edinburgh. He is an active academic surgeon with experience in undergraduate medical education and surgical training. Previously, Prof Lai was the Director of the Office of Medical Education at Faculty of Medicine, CUHK and the Honorary Chief of Service in the Department of Surgery at the Prince of Wales Hospital (2008–2018). Prof Lai has actively participated in the work of the College of Surgeons of Hong Kong, serving as Vice President (2010–2013), Censor-in-chief (2013–2016) and President (2016–2019). He also previously served as the Deputy Chairman of the Academy's Education Committee.

Prof Lai has developed an interest in administrative medicine, medical law and mediation. He was elected as a fellow of the Royal Australasian College of Medical Administrators, a fellow of the Faculty of Public Health (UK) and a fellow of the Hong Kong College of Community Medicine (Administrative Medicine) in 2018. He studied for a master's degree in medical law at the University of Northumbria and he is an accredited mediator in Hong Kong under the Hong Kong Mediation Accreditation Association Limited.

Dr Wing-cheong Leung
Honorary Secretary



Dr Wing-cheong Leung graduated from the Medical School of The University of Hong Kong (HKU). He completed his specialist training in Obstetrics and Gynaecology at Tsan Yuk Hospital and Queen Mary Hospital. Dr Leung has subspecialised in maternal and fetal medicine and has trained overseas at the Perinatal Centre at the University of Toronto in Canada and at the Fetal Medicine Centre at University College London in the UK. He is a subspecialist in maternal and fetal medicine accredited by the Royal College of Obstetricians and Gynaecologists (UK) and by Hong Kong College of Obstetricians and Gynaecologists in 2005. He also gained a MD (HKU). His current positions include Consultant Obstetrician & Chief-of-Service, Dept of O&G, Kwong Wah Hospital; Honorary Clinical Professor, Dept of O&G, HKU; Honorary Clinical Professor, Dept of O&G, The Chinese University of Hong Kong; and Immediate Past President (2016-18), Hong Kong College of Obstetricians and Gynaecologists.

With his new position as the Honorary Secretary, Dr Leung would like to contribute to the Academy in upholding the specialist training and standard of specialist practice during the global pandemic of COVID-19.

Prof Eric Wai-choi Tse
Honorary Treasurer



Prof Eric Tse is currently Clinical Professor in the Department of Medicine, The University of Hong Kong (HKU), and specialist in Haematology and Haematological Oncology. He graduated MBBS with the John Anderson Gold Medal from HKU and pursued post-graduate study at the University of Cambridge. He obtained his PhD and was awarded the Max Perutz Prize from the MRC Laboratory of Molecular Biology, Cambridge.

In addition to his clinical, research, and teaching responsibilities, Prof Tse holds leadership positions in various local and international organisations. He is Assistant Dean (Enabling Platforms) at the LKS Faculty of Medicine at HKU and Chairman of the HKU/HA HKW Institutional Review Board. He is also Chairman of the Specialty Board of Haematology and Haematological Oncology of the Hong Kong College of Physicians. Prof Tse is a past Chairman of the Hong Kong Society of Haematology and is currently serving the American Society of Hematology (ASH) as a Steering Committee Member of

the Highlight of ASH programme.

Prof Tse hopes that, with his broad experience and expertise, he can make a valuable contribution to the smooth and efficient operation of the Academy.

Prof Martin Wong is a specialist in Family Medicine and a researcher in the field of cancer screening and chronic disease prevention. Professor Wong has around three hundred publications in international peer-reviewed journals, and received over 15 research awards for studies in his research area. He is the Co-Chair of the NCD stream of APRU Global Health Programme; Co-Chairman of the Grant Review Board, Health and Medical Research Fund, Food and Health Bureau (FHB); a member of the Expert Advisory Panel in Implementation Science of the HKSAR government, and a member of the Research Council of the FHB. He has been a reviewer of the Medical Research Council (MRC), United Kingdom; expert reviewer of the National Medical Research Council (NMRC), Singapore; external examiners of doctoral thesis in various Universities; and an external reviewer of the Public Policy Research Funding Scheme, Research Grant Council (RGC) of Hong Kong. He has been selected for the “Master Teacher” and the “Annual Teacher of

the Year Award” for seven years. In 2016, he was conferred as an Honorary Fellow by the Hong Kong Academy of Nursing, and Fellows of various Academies, Royal Colleges and professional societies. He was appointed as an Adjunct Professor of the Peking Union Medical College and Adjunct Professor of Global Health by the Peking University.

As Editor, Prof Wong has overseen solid improvements in the Hong Kong Medical Journal over the past few years, and he intends to continue building the reputation and impact of the Journal in future.

Annual subscription 2021

Demand notes for annual subscription were sent in January 2021. Fellows are strongly advised to settle the payment as soon as possible.

Reminders:

1. Fellows are required to make payment of annual subscription on or before 30 June 2021. A surcharge of \$1,000 or pro-rated rate where applicable will be levied for overdue payment.
2. All payments must be received before 30 September 2021.

According to Bylaw 6.4:

If a member's fee or any other moneys due by a member to the Academy is not received by the Academy within 9 months after such payment falls due, despite two written reminders by the Academy to pay, the member shall automatically forfeit his membership.

3. The due annual subscription will be debited automatically from the designated bank or credit card account.
4. Honorary Fellows, Fellows aged >70 years, or Fellows who reached age 70 years in the past subscription year do not need to pay the annual subscription.
5. Fellows who reside outside Hong Kong or who have retired from all remunerative practice/job/business must submit formal written requests for reduced rates before 31 December 2021. The reduced rate will take effect from the following year (i.e., 2022).

Credit card online payment service

HKJCDPRI Updates

Overview of COVID-19 Vaccines

To help the general public in Hong Kong to better understand the pandemic, the HKJCDPRI has kept up to date with the development of the COVID-19 vaccine, and regularly disseminates the latest information via social media and our website. Dr Jimmy Chan is President of the Hong Kong Association for Conflict and Catastrophe Medicine and he is Regional Director (HK) of Advanced HazMat Life Support International, based in the US. In January 2021, Dr Chan provided an overview of the current status of COVID-19 vaccine deployment in Hong Kong, providing information about the types of vaccine available and the benefits of vaccination. He also explains some precautions that people should be aware of in order to prepare for receiving the vaccine.

COPE COVID-19 booklet and pilot programme on storytelling activities

Effective storytelling is a fine and beautiful art. A good storyteller can hold the audience's interests, unleash their imagination, and inspire them to think and discuss the educational messages of the story. In collaboration with the Little Green Feet Parent-Child Reading Club, HKJCDPRI launched a pilot programme on storytelling activities. Three storytelling sessions were held via Zoom for students of Pok Oi Hospital Chan Kwok Wai Primary School on 18 December 2020, and 15 and 29 January 2021.

HKJCDPRI has been collaborating with COPE to translate and promote a series of books that aim to improve the disaster resilience of children. In the storytelling activities, the COPE COVID-19 booklet and another two picture books were used to weave a tale in which the 80 primary school students learnt how the virus was spread, and how to keep safe and positive during the COVID-19 pandemic. After listening to the lockdown diaries of other children from different nations, the students understood that they were not alone in facing the challenges of the pandemic and should embrace life with love and hope during hard times.

The storytelling activities were warmly received by the participating teachers and students. Most of them were impressed by the storyteller's captivating narrating skills and found the story amusing, meaningful, and useful in helping them cope with the challenges during the COVID-19 pandemic. They would also like to learn more about disaster preparedness and response.

Since the COVID-19 pandemic is still severe, we will continue to conduct storytelling activities in 40 more primary schools to educate students how to maintain their mental wellness during the COVID-19 pandemic. When the pandemic subsides, our storytellers will use other COPE booklets—with themes including earthquakes, tsunamis, floods, cyclones, and storm surges—to advocate disaster education and disaster resilience in Hong Kong. We hope that these storytelling activities will complement and mirror the success of our school drama, "Preparing Kids for Disasters"!

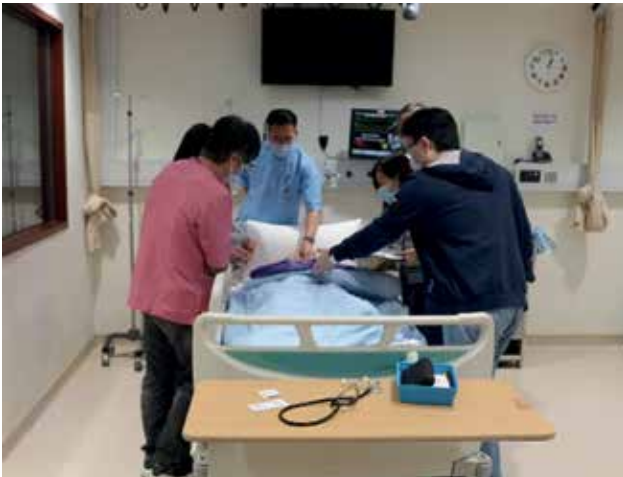

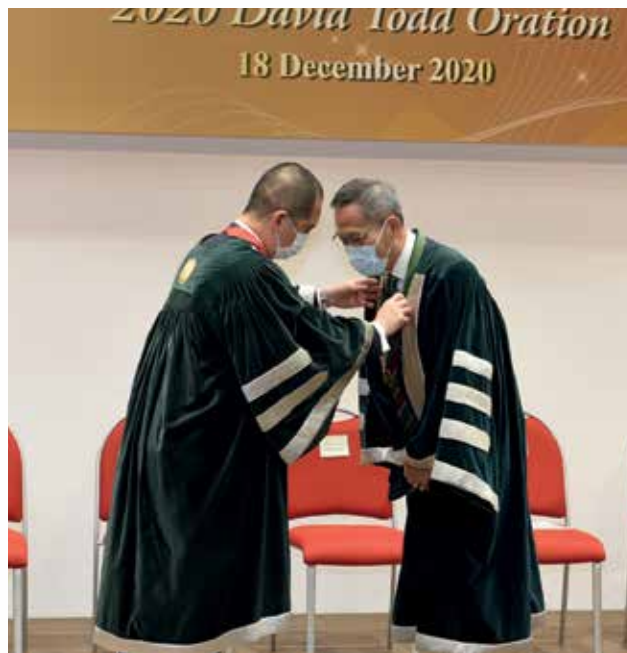
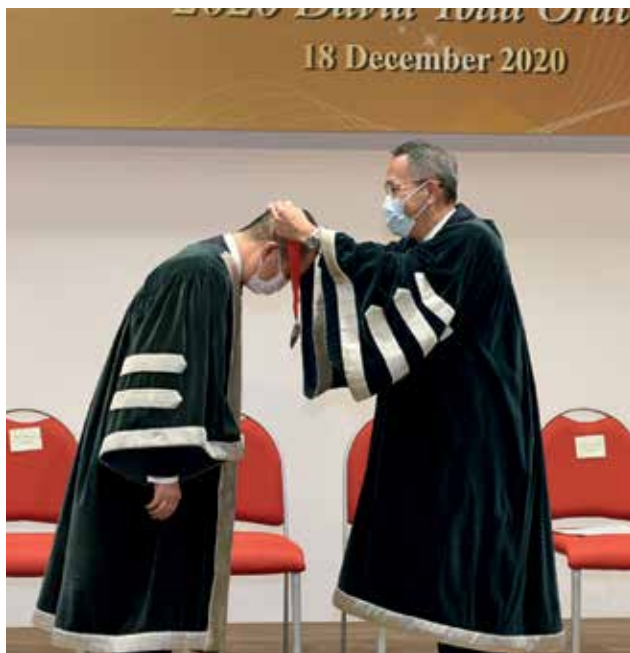

Seminar on Disclosure, Apology and Alternative Dispute Resolution: Practical Tips and Case Studies, 6 December 2020

The Seminar on Disclosure, Apology & ADR: Practical Tips and Case Studies was successfully held on 6 December 2020. Organised by the Disclosure, Apology and Alternative Dispute Resolution (DAADR) Task Force of the Academy's Professionalism and Ethics Committee (PEC), the Seminar attracted over 260 online and onsite attendees from various specialties.

Following a successful seminar held on 18 July, at the request of the attendees, the DAADR Task Force has organised a follow-up seminar to provide more practical tips on apology, disclosure and mediation, through studies of local cases and discussions by a panel of experts from both the medical and the legal fields, as well as colleagues from Medical Protection Society and Hospital Authority.

Prof Gilberto Leung, PEC Co-chairman and newly elected President of the Academy, delivered the Opening Remarks and chaired the first Plenary Session under the theme "Apology and Open Disclosure after Mishaps". Dr James Chiu, the other PEC Co-chairman, also delivered a talk on Apology Ordinance in this Session. Prof Paul Lai, newly elected Vice-President (Education and Examinations) of the Academy, delivered a talk on Mediation in the second Plenary Session chaired by Dr So Hing Yu under the theme "When Complaints Become Disputes" and delivered the Closing Remarks.

Invited speakers, including Dr Sara Ho, Chief Manager, Patient Safety & Risk Management, Hong Kong Hospital Authority, shared their insightful views and practical tips for medical professionals on apology, open disclosure and mediation through local case studies in the two Panel Discussions. Dr Rob Hendry, Medical Director of Medical Protection Society also joined the second Panel Discussion online from UK.
